### Main purpose

The teacher will:

- Fulfil the professional responsibilities of a teacher, as set out in the School Teachers' Pay and Conditions Document
- Meet the expectations set out in the Teachers' Standards
- Play an active part in all aspects of school life and as part of the Galileo Academy Trust

### Duties and responsibilities

#### Teaching

- › Plan and teach well-structured lessons to assigned classes, following the school's plans, curriculum and schemes of work
- › Assess, monitor, record and report on the learning needs, progress and achievements of assigned pupils, making accurate and productive use of assessment
- › Adapt teaching to respond to the strengths and needs of pupils
- › Set high expectations which inspire, motivate and challenge pupils
- › Promote good progress and outcomes by pupils
- › Demonstrate good subject, and curriculum knowledge
- › Participate in arrangements for preparing pupils for external tests

#### Whole school organisation, strategy and development

- › Contribute to the development, implementation and evaluation of the school's policies, practices and procedures, to support the school's vision and values
- › Make a positive contribution to the wider life and ethos of the school.

- › Work with others on curriculum and pupil development to secure coordinated outcomes.
- › Provide cover, in the unforeseen circumstance that another teacher is unable to teach.

### **Health, safety and discipline**

- › Promote the safety and wellbeing of pupils.
- › Maintain good order and discipline among pupils, managing behaviour effectively to ensure a good and safe learning environment.

### **Professional development**

- › Take part in the school's appraisal procedures.
- › Take part in further training and development to improve own teaching.
- › Take part in the appraisal and professional development of others, where appropriate.

### **Communication**

- › Communicate effectively with pupils, parents, and carers.

### **Working with colleagues and other relevant professionals**

- › Collaborate and work with colleagues and other relevant professionals within and beyond the school.
- › Develop effective professional relationships with colleagues.

### **Personal and professional conduct**

- › Uphold public trust in the profession and maintain high standards of ethics and behaviour, within and outside school.
- › Have proper and professional regard for the ethos, policies, and practices of the school, and maintain high standards of attendance and punctuality.
- › Understand and act within the statutory frameworks setting out their professional duties and responsibilities.
